

Frequently Asked Questions

General Questions

Q: My PIN doesn't work?

A: If you receive the message "PIN not valid yet" this means that you are trying to complete the survey before the start of your survey week. Please try again after the start of your allocated survey week. If you receive any other error message relating to your PIN please email tas.administration@admin.cam.ac.uk.

Q: How do I allocate time spent on leave?

A: If you were on leave for all or part of the week please tick the relevant leave box at the top of the form.

This helps us identify non-respondents by omitting individuals who were on leave during the whole week.

If you were on leave for part of the week please tick the appropriate leave box and enter the hours worked during the rest of the week. Once the form is submitted percentages are made up of time spent working only.

If you were on paid leave of absence, e.g. research leave, such time should be recorded on the TAS by allocating it according to the type of activity being carried out, e.g. RC-funded Research. Time spent on other leave (e.g. annual leave, sick leave, maternity leave, and unpaid leave of absence) should not be recorded on the TAS.

Q: Definition of a week / What is 100%?

A: All time spent on university or college activities during the week, including weekend and evening work.

This excludes any private work. Please note there is provision to identify College Time separately on the form, and to record time spent on College-funded Research as Direct Research.

Q: What is the assumed total number of working hours per week, which presumably serves as the basis of percentages?

A: There is no assumed total number of working hours per week. The objective of the TAS exercise is to collect information on how individuals spend their time using percentage of time spent on teaching, Research, and other activities.

Q: It is not a typical working week for me. Can my week be changed?

A: It is not possible to change your survey week as the selection is random. We do understand that some weeks of the year will not be typical weeks (e.g. bank holidays, start or end of term time, fieldwork periods, conferences, etc.). Every week, however atypical, is still part of the



University's activities and we'd like to know about it. The process used, sampling across the year, means that when the data for all weeks are aggregated it will produce average percentages in order to get the overall activity pattern for each department.

Q: I have more than one role/contract with the University, what working hours should I include?

A: If you have more than one role or work across departments but only one current employment contract then include all of your University working hours.

If you have more than one role and more than one current employment contract, please contact us by email tas.administration@admin.cam.ac.uk before you complete the TAS survey form to clarify which of your roles has been selected.

Q: How do I allocate travel time?

A: Time spent travelling to and from your usual place of work must not be allocated. Time spent travelling on University work should be allocated according to the purpose of the trip (e.g. to/from lectures or committees). If a sponsor is funding the time, it should be allocated to teaching, Research or other activities as appropriate. Time spent working while travelling should be allocated to that activity. If neither of these apply, allocate the time to support.

Q: Where should I record Public Engagement work?

Public engagement work should be recorded under Support for Teaching or Research according to the main purpose of the activity. For example, if it mainly relates to widening participation including admissions outreach, it should go under Support for Teaching. If it's part of a research project, then it should be recorded under the relevant Research sponsor as a directly funded activity. If it does not relate to a specific sponsor then this can be recorded under Support for Research.

If the public engagement is "service to society" and not related with Teaching or Research it should be recorded as General Support.

Q: How do I allocate work that contributes equally to both Teaching and Research (e.g. writing books reporting Research but also used for teaching)?

A: Divide it 50-50 between the relevant categories.

Q: Colleagues at other Universities have completed more detailed TAS schedules, why is Cambridge's approach different?

A: The University has taken a light touch approach to the TAS exercise as opposed to some other universities who have imposed a complex time recording process. It is hoped that the University's approach provides a balance in producing a good indication of time allocation without introducing a cumbersome process, which would prove to be an additional burden for staff. The University's TAS method has been verified by an independent statistician.

Q: How do I allocate time spent on work (e.g. preparing reading lists) for both lectures and college supervisions?

A: If the work is primarily for lectures, record it under University duties; if it is primarily for College-paid teaching, record it under College duties; if it serves both equally, record it as 50:50.

Q: How do I allocate time spent on examining?

A: To Preparation/Assessment under Direct Teaching.

Q: How should I allocate time spent preparing material for teaching?

A: Preparing material specifically for existing or agreed new courses counts as Preparation/Assessment in Direct Teaching. Initial preparatory work to develop possible new courses is Support for teaching. Preparing non-research papers and books for general use in teaching is Support for teaching.

Q: How do I allocate time spent talking to students after lectures?

A: To Direct Teaching (if specifically related to the lecture).

Q: How should I allocate Veterinary School clinical work?

A: If the main purpose of the work is treatment record this in Other Activities as 'Clinical Services'. If the main purpose of the activity is teaching record this in 'Direct Teaching'.



Q: How do I allocate time spent external examining (or similar) students at other Universities?

A: If the students being examined are undergraduate students or taught postgraduates, this time should be entered under Preparation/Assessment in Direct Teaching.

If the students are research postgraduates, this time should be allocated under PGR supervision/training.

Research Activities

Q: How do I allocate time spent on Research that is partly University-funded and partly externally funded?

A: Research that is even partly externally funded counts as externally funded Research. To count as University-funded, Research must be wholly funded by the University.

Q: How do I know which category is the right one for my sponsor?

A: For the academic year 2024-25 onwards the Direct Research categories have changed. If you are recording your time for a week in August 2024 or beyond, first establish the region of the source of the sponsor funds. either UK, EU or Non-EU. Then allocate to one of the categories available within the region e.g. Charity or Industry.

Q: How do I allocate time spent if my sponsor funding comes from a multinational organisation?

A: If you are recording your time for a week in August 2024 or beyond, for a multinational organisation choose the location of the office making the award e.g. a multinational with a US subsidiary making the award should be allocated to a Non-EU category.

Q: How do I allocate time spent on research projects jointly funded by sponsors of different types (e.g. partly by a research council and partly by industry)?

A: Allocate time pro rata to the funding from sponsors of each type.

Q: How do I allocate time spent on University-funded work that may be sold commercially at a later date?

A: If the original purpose of the work was Research, it is University-funded Research. If it was commissioned by a private sponsor and is Research (e.g. was returned under the RAE), it should be allocated to the appropriate sponsor type.

Q: I am doing an externally funded research fellowship, should I complete a TAS form?

A: If you are on a 100% research fellowship you do not need to complete a TAS form. Please let us know if that is the case so that we can remove you from the survey list.

If you are doing a part-time fellowship, please record your FTE (full-time equivalent) percentage for University work and only record the time you have spent working for the University during your allocated week on your form.



Q: How should I allocate time spent preparing for Research?

A: The preparation of research reports, papers and books is Direct Research. Research involved in designing and planning postgraduate research programmes, and drafting project proposals (for potential funders, etc.) is Support for Research.

Q: What is the difference between scholarly activity and Research?

A: Scholarship is time spent updating or maintaining your existing knowledge or skills. The knowledge base already exists elsewhere. Therefore scholarship is different from Research, in particular from institution-funded Research, however if the advancement of knowledge can be specifically related to an activity, e.g. research project, then it can be classified as direct Research.

Q: How do I allocate time spent at research conferences?

A: Time spent preparing and giving a research paper, or in sessions directly relevant to your own research, should be allocated to Research. Time spent in other sessions should be allocated to Support for Research.

Q: How do I allocate time spent external examining (or similar) PhD students at other Universities?

A: Time spent reading PhD theses and attending other universities for viva examinations should be entered under PGR supervision/training.

Q: How do I allocate time spent training PGR students when I am not the supervisor?

A: This time should still be allocated under PGR training/supervision.

Q: Where should I record the hours spent on my College duties?

A: If you have spent time on Research funded by a Cambridge College, then record this time under Direct Research then "College funded Research". Any other time spent on College duties is excluded from the survey and the TRAC statutory return, so you don't need to record it.
